# BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF JEFFERSON, STATE OF ARKANSAS, AND AN ORDINANCE TO BE ENTITLED:

# AN ORDINANCE APPROVING A COUNTY-WIDE HIRING FREEZE; PRESCRIBING OTHER MATTERS PERTAINING THERETO;

WHEREAS, the Quorum Court of Jefferson County has determined that due to the ongoing

County-wide economic crisis, it is in the best interests of the County and public to continue the

hiring freeze through December 31, 2022; and

WHEREAS, the institution of a hiring freeze will also subject all vacant positions

of county employment to the hiring freeze.

NOW, THEREFORE, BE IT ORDAINED:

ARTICLE I. This Ordinance shall apply to all regular, temporary, and acting

positions of county employment regardless of which branch of government, except:

- (1) the chief administrators of the circuit and district courts;
- (2) commissioned law enforcement positions within the sheriff's office;
- (3) custody and corrections officers within the sheriff's office;
- (4) juvenile intake, probations and corrections officer positions at the Jack Jones Juvenile Detention Center;
- (5) any position funded entirely by one or more grants, the use of which is restricted by law or contract; and
- (6) temporary positions supporting within the elections division of the county.(7)MECA

ARTICLE II. There is hereby imposed a hiring freeze on all positions of county

employment for non-emergency personnel in all departments. The filling of any current or future vacancy is prohibited except as expressly provided herein.

AN ORDINANCE APPROVING A COUNTY-WIDE HIRING FREEZE; PRESCRIBING OTHER MATTERS PERTAINING THERETO;

(1) The Quorum Court may by motion exempt one or more specific

appointments from application of this section upon a determination that

the appointment is;

- (a) Necessary for performance of a critical health or safety function;
- (b) Necessary for satisfaction of a legal mandate;
- (c) Necessary for efficient and cost-effective operation of the county; or
- (d) Substantially funded by a federal or state grant or other dedicated revenue source and is necessary to carry out a county obligation under a related grant or other contract.
- (2) Any action exempting an appointment from application of this Ordinance

will be made at a public meeting after consultation with the requesting

elected official as provided herein.

(3) Any county elected official or court administrator may request that the

Quorum Court exempt an appointment from application of this ordinance. The request must be in writing and shall include relevant fiscal information and the recommendation of the County Judge and department of human resources, if any. The County Judge shall process the request promptly and submit it to the Quorum Court, which in no event shall occur more than five working days after the written request is delivered to the County Judge, and the requesting official shall add such additional information as the County Judge deems appropriate.

ARTICLE III. This ordinance shall not apply to any bona fide offer of county employment tendered and accepted prior to the adoption and actual notice of this ordinance, regardless of when the employee actually begins work for the County. The County Clerk shall forthwith distribute copies of this ordinance to all county elected officials and department heads and to such other county officers as directed by the Chairperson of the Finance Committee.

ARTICLE IV. The Jefferson County Quorum Court finds that this ordinance is necessary to respond to recent 2021 and 2022 projected ongoing County-wide crisis, that immediate action is needed to help curtail expenditures, and that this ordinance is necessary for the support of county government and its existing institutions. Based on the foregoing, the Quorum Court declares that an emergency exists and this ordinance shall take effect immediately. ORDINANCE NO. 2022- \_\_\_\_

BE IT ENACTED BY THE QUORUM COURT OF JEFFERSON COUNTY, STATE OF ARKANSAS, AN ORDIDNACE TO BE ENTITLED:

"AN ORDINANCE PROHIBITING UNREASONABLY LOUD NOISES AND DISTURBANCE OF THE PEACE IN JEFFERSON COUNTY; LEVYING A FINE FOR AN VIOLATIONS OF SUCH, AND FOR OTHER PURPOSES."

- <u>Section 1.</u> The causing of any unread really loud and disturbing noises of such volume or duration as to be detrimental to the life or Health of any individual, or to disturb the public peace and welfare is prohibited.
- <u>Section 2.</u> In addition to the disturbances set forth in Section 1, the following are specifically prohibited; the playing of any radio, stereo, music reproduction system or musical instruments in such manner or of such volume, particular between the hours of 10 p.m. and 6 a.m., asked to disturb the peace and quiet of residence; and sustained engine noises.
- <u>Section 3.</u> Penalty. Any violation of this ordinance shall be punishable by fine not to exceed five hundred dollars (\$500); double that sum for each repetition thereof. The Jefferson County Sheriff's Office shall enforce this ordinance.
- <u>Section 4.</u> This ordinance covers only those areas of Jefferson County, Arkansas which are unincorporated.
- <u>Section 5.</u> Severability. If any part of this ordinance is held invalid, such invalidity shall not affect any other portion of this ordinance
- <u>Section 6.</u> Repeal of Conflicting Ordinances and Resolutions. All laws and parts of laws in conflict with this ordinance are hereby repealed.

<u>Section 7.</u> Codification. This ordinance shall be codified in the Jefferson County Code of Ordinances and the sections may be renumbered and re-lettered to accomplish such intention.
