BE IT ENACTED THE QUORUM COURT OF THE COUNTY OF JEFFERSON, STATE OF ARKANSAS.

Article I. The County Clerk is authorized to reimburse County Employees who are 65 or older that voluntarily leave the County's insurance plan. The County Clerk will compensate these employees the premium Medicaid, Medicaid supplement Part B and Part D drug prescription premium. Reimbursement is not to exceed the employee-only premium rate.

- (a) The employee will need proof of payment
- (b) This includes employees who will turn 65 who voluntarily leave the County's insurance plan.
- (c) Not to include paying claims
- (d) Employees will still be obligated to pay the portion that was paid to the County.
- (e) County Clerk can pay the premium instead of the reimbursement.
- (f) Verification in writing the county insurance was waived
- (g) Proof of plan B and D was approved.

AN APPROPRIATION ORDINANCE FOR EMPLOYEE'S COMPENSATION FOR UNUSED
SICK LEAVE AT RETIREMENT

BE IT ENACTED THE QUORUM COURT OF THE COUNTY OF JEFFERSON, STATE
OF ARKANSAS.

(a) Upon retirement or death, any employee or beneficiary of any employee of Jefferson County shall receive compensation for accumulated unused sick leave as follows:

(1) If the employee has accumulated at least fifty (50) days, but fewer than sixty (60) days of sick leave, the employee shall receive an amount equal to fifty percent (50%) of the number of accrued sick leave days rounded to the nearest day multiplied by fifty percent (50%) of the employee's daily salary;

(2) If the employee has accumulated at least sixty (60) days, but fewer than seventy (70) days of sick leave, the employee shall receive an amount equal to sixty percent (60%) of the number of accrued sick leave days rounded to the nearest day multiplied by sixty percent (60%) of the employee's daily salary;

(3) If the employee has accumulated at least seventy (70) days but fewer than eighty (80) days of sick leave, the employee shall receive an amount equal to seventy percent (70%) of the number of accrued sick days rounded to the nearest day multiplied by seventy percent (70%) of the employee's daily salary; and

(4) If the employee has accumulated at least eighty (80) or more days of sick leave, the employee shall receive an amount equal to eighty percent (80%) of the number of accrued sick leave days rounded to the nearest day multiplied by eighty percent (80%) of the employee's daily salary.

(b) For purposes of this section, the employee's daily salary shall be determined by dividing the annual salary by two hundred sixty (260).

(c) In no event shall an employee or beneficiary of an employee receive an amount that exceeds seven thousand five hundred dollars (\$7,500) upon retirement or death due to the provisions of this section.

(d) The employee must qualify for APERS (Arkansas Public Employees Retirement System) Normal Retirement.

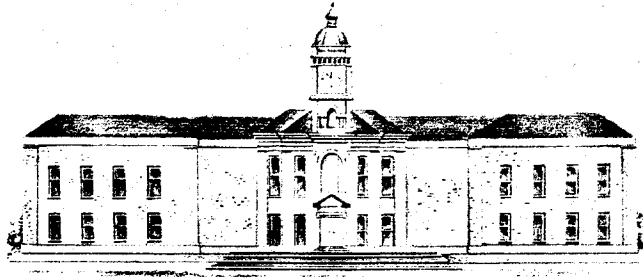


