AN APPROPRIATION ORDINANCE TO TRANSFER FUNDS FROM 3046 AMERICAN RECOVERY PLAN TO 4802 SPECIAL PROJECT CONSTRUCTION FUND – UAPB.

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF JEFFERSON, STATE OF ARKANSAS.

Article I. The County Judge is now authorized to approve a transfer of funds for \$3,000,000.00 from 3046 American Recovery Plan to 4802-0100-3114 Special Project Construction Fund – UAPB.

Article II. The County Judge is allowed to authorize the appropriation distribution as outlined in the Memorandum of Understanding (MOU) attached hereto.

Article III. The County Treasurer is authorized to transfer funds for \$3,000,000.00 from 3046 American Recovery Plan to 4802 Special Project Construction Fund – UAPB.

Article IV. American Recovery Plan funds may be used to pay for “government services” in an amount equal to the revenue loss experienced by the recipient due to the COVID-19 public health emergency up to \$10,000,000 (not to exceed the recipient’s total award amount) to spend on government services.

Article V. “Government services” include projects that would be eligible under other eligible use categories such as maintenance, improvement, or new construction of public school facilities, including those that address over-crowding and capacity constraints and respond to health and safety concerns, among other purposes. Recipients may also use American Recovery Plan funds for developing neighborhood features that promote improved health and safety outcomes, such as parks, green spaces, and recreational facilities.

Article VI. A recipient may transfer funds to any entity to carry out, as a subrecipient, an eligible activity on behalf of the recipient.

Article VII. This Appropriation Ordinance shall be in full force and effect from and after its passage and approval.

AN APPROPRIATION ORDINANCE TO TRANSFER FUNDS FROM 3046 AMERICAN RECOVERY PLAN TO 4802 MUNICIPAL SPECIAL PROJECT CONSTRUCTION FUND – CITIES OF ALTHEIMER, HUMPHREY, AND REDFIELD (WATER & SEWER PROJECTS).

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF JEFFERSON, STATE OF ARKANSAS.

Article I. The County Judge is now authorized to approve a transfer of funds for \$2,100,000 from 3046 American Recovery Plan to 4802-0100-3114 Municipal Special Project Construction Fund – Cities of Altheimer, Humphrey, and Redfield (Water & Sewer Projects) for the purpose of water and sewer projects that would be eligible under the EPA's Clean Water State Revolving Fund (CWSRF) or the EPA's Drinking Water State Revolving Fund (DWSRF).

Article II. The County Judge is allowed to authorize the appropriation distribution as outlined below.

Article III. The County Treasurer is authorized to transfer funds for \$2,100,000 from 3046 American Recovery Plan to 4802 Municipal Special Project Construction Fund – Cities of Altheimer, Humphrey, and Redfield (Water & Sewer Projects).

Article IV. American Recovery Plan funds may be used to pay for "government services" in an amount equal to the revenue loss experienced by the recipient due to the COVID-19 public health emergency up to \$10,000,000 (not to exceed the recipient's total award amount) to spend on government services.

Article V. "Government services" include projects that would be eligible under other eligible use categories, such as projects that would be eligible under the EPA's Clean Water State Revolving Fund (CWSRF) or the EPA's Drinking Water State Revolving Fund (DWSRF).

Article VI. A recipient may transfer funds to any entity to carry out, as a subrecipient, an eligible activity on behalf of the recipient.
